

**SOUTH COAST MALL EASTER EGG HUNT PROMOTION: 2017
TERMS AND CONDITIONS ("PROMOTION")**

This Promotion, conducted and organised by the South Coast Mall, is subject to these Terms and Conditions ("T's and C's"), as may be amended from time to time. Please read the T's and C's carefully and pay special attention to all the terms printed in bold.

1. PROMOTER

- 1.1 This Promotion is promoted by Redefine Properties Limited (Registration Number:1999/018591/06) ("**Landlord**").
- 1.2 **The Landlord will make a final and binding decision in respect of all matters relating to the results, qualifiers and disputes relating to the Promotion and no correspondence will be entered into.**
- 1.3 If considered necessary, the Landlord reserves the right to amend the T's and C's by providing reasonable prior notice.

2. RULES

- 2.1 To enter the Promotion a participant ("**Participant**") must be in possession of a valid South African identity document. If the Participant is younger than 18 years old, the Participant must be able to show consent by a guardian or parent and be accompanied by such guardian or parent, if the Participant receives a prize.
- 2.2 The Promotion may not be entered into by any director, member, partner, employee, agent, consultant, and tenant of the Landlord, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
- 2.3 The Promotion runs from 31 March 2017 until 21 April 2017 ("**Promotion Period**"). Any entries received after the Promotion Period will not be taken into consideration.
- 2.4 To enter the Promotion, a Participant will be required to, for the duration of the Promotion Period to-
 - 2.4.1 visit the South Coast Mall in order to find the 5 (five) easter egg bunnies to be displayed in the windows of 5 (five) shops and/or restaurants at the South Coast Mall; and
 - 2.4.2 record his/her correct contact details on the entry form relating to the Promotion ("**Entry Form**"). Should a Participant provide incorrect contact details to the Landlord, the Landlord in its sole discretion, may disqualify such a Participant automatically. Entries that are unclear, illegible or contain errors will be declared invalid. The Landlord reserves the right to disqualify any entry should fraud or cheating be suspected. Entry Forms may be obtained from any of the shops and/or restaurants at the South Coast Mall as well as Centre Management; and
 - 2.4.3 answer the questions posed in the Entry Form correctly; and
 - 2.4.4 place the duly completed Entry Form in the Easter Egg Hunt boxes ("**Entry Boxes**"). The 4 (four) Entry Boxes are placed at:
 - (i) the South Coast Mall management office, which is situated next to Game (open from 8 am to 5 pm on week days only); and
 - (ii) Centre Court 2; and
 - (iii) In front of Ocean Basket; and
 - (iv) In front of the entrance of Game.
- 2.5 **Upon compliance with 2.4 a Participant will automatically be deemed to have entered the Promotion.**
- 2.6 A Participant may enter as many times as he/she wishes, but can only win once.

3 **SELECTING A WINNER AND THE PRIZES TO BE AWARDED**

- 3.1 4 (Four) South Coast Mall vouchers to the value of R1,000.00 (One Thousand Rand) each ("**Prizes**") will be given away, to 4 (four) Participants ("**Prize Winner**") at the end of the Promotion Period.
- 3.2 **None of the Prizes are transferable and the Prizes will not be changed or deferred for any reason whatsoever.**
- 3.3 All Winners must collect their prizes in person, and if younger than 18 years old, must to be accompanied by a parent/ guardian who should be willing and able to provide the necessary permissions and consent.
- 3.3.1 Prizes to be collected from:
The Centre Management Offices, South Coast Mall, Izotha Road, Shelley Beach;
- 3.3.2 Prizes to be collected during office hours, Monday to Friday between 08:00 - 17:00.
- 3.4 The Landlord will use reasonable efforts to contact each Winner on the telephone number or *via* the email address provided on the Entry Form. If the Landlord is unable to reach any Winner for whatsoever reason, such a prize winner will be disqualified and the selection or draw of a replacement entry shall take place, as may be applicable. Such a replacement winner shall be contacted by the Landlord on the telephone number or *via* the email address provided on the Entry Form, as soon as reasonably practicable and shall be required to respond to the Landlord set out in such correspondence.

4 **GENERAL**

- 4.1.2 be obtained from South Coast Mall centre management during week day office hours from 8 am to 5 pm, or;
- 4.1.3 be requested telephonically on telephone number 039 315 7515.
- 4.2 **The Landlord reserves the right to terminate the Promotion with immediate effect before the end of the Promotion Period at any time, if deemed necessary in its sole discretion or if circumstances arise outside of its control. No Participant will have any claim against the Landlord for such a termination.**
- 4.3 **Participation in the Promotion constitutes automatic acceptance of the T's and C's contained herein and the Participant agrees to abide by the T's and C's.**
- 4.4 **Winners may not win any South Coast Mall Promotion more than once in a 30-day period. Any winners drawn who have won in the last 30 days will be disqualified from any such Promotion and another winner will be drawn.**
- 4.5 All Winners in respect of the Promotion may be requested to be photographed so that their photographs may be used for future promotional post Promotion purposes in relation to South Coast Mall.
