COMPETITION TERMS & CONDITIONS (“T’s & C’s”)

Date these T’s and C’s were first published: 14 November 2019

Date these T’s and C’s were last changed: 18 November 2019

These Competition T’s & C’s, as may be amended from time to time, explain your rights and duties in respect of the Competition. If you take part in this Competition and/or accept any prize, these T’s and C’s will apply to you. Please read the T’s and C’s carefully, and pay special attention to all the terms printed in bold.

1.	Name of the Competition:	<i>Southcoast Mall Turnover Competition</i>
2.	Promoter’s details:	This Competition is conducted and organized by Southcoast Mall (“ Mall ”) and promoted by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ Landlord ”). In these T’s & C’s we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
IMPORTANT INFORMATION		
3.	Eligibility: Who may enter the Competition?”	To enter the Competition a participant (“ Participant ”) must be 18 (eighteen) years or older and must be in possession of a valid South African identity document or passport.
4.	Who cannot enter the Competition?	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
5.	Entry Period:	The Competition will run from 1 November 2019 until 30 November 2019 (“ Competition Period ”). Any entries received after the Entry Period will not be taken into consideration.
6.	How to enter?	To enter the Competition, a Participant will be required to complete the following steps: <ul style="list-style-type: none"> a. visit the Mall; b. spend an amount of R600.00 (Six Hundred Rand) or more, excluding food or alcohol, on a single till slip (“Till Slip”) at any store, outlet and/or leisure venue (“Store”) at the Mall during trading hours;

		<p>c. write your name, surname and contact details at the back of the Till Slip; and</p> <p>d. drop the Till Slip in one of three entry boxes at the Mall located at: (i) entrance 1 next to Seattle Coffee Shop; (ii) entrance 2 next to Sleepmaster; and (iii) at the food court adjacent to Dischem (“Entry”).</p> <p>Upon compliance with a-d above, a Participant will automatically be deemed to have entered the Competition.</p>
7.	Limitation on entries	A Participant may enter as many times as he/she wishes during the Competition Period but can only win once. Participants are advised that each Till Slip constitutes a single Entry and accordingly, each Till Slip may only be used once.
8.	How will the Winner/s be selected?	Upon the expiry of the Entry Period the Landlord will select 20 (twenty) winners (“ Winners ”) through a random draw which will be overseen by an independent auditor.

10.	The prizes	<p>Each Winner will receive a Southcoast Mall branded cooler bag to the value of R250.00 (Two Hundred and Fifty Rand). (“Prize”).</p> <p>None of the prizes are transferable and will not be changed, deferred or exchanged for cash for any reason whatsoever.</p>

How will the Winner/s be informed?	<p>The Landlord will use all reasonable efforts to contact the Participant through the contact details provided in the Till Slip used to enter the Competition.</p> <p>If the Landlord is unable to contact or reach the Winner within 7 (seven) days of having informed the Winner of the outcome of the Competition, the Entry for that Participant will be disqualified, and an alternative Entry will be drawn, and such Winner will be contacted. That Winner will also be contacted by the Landlord as soon as reasonably practicable.</p>

Upliftment of prizes	<p>Once the Winner has been announced, the Winner must make his/her way to the centre management offices (“Centre Management”) located at the Mall offices, ground floor, during trading hours.</p> <p>The Winner must appear in person and be able to furnish The Landlord with a valid South African identity document or passport upon upliftment of the Prize.</p>
13.	Deadline for claiming prizes	If the Winner does not collect the Prize within 14 (fourteen) days of being informed that he/she has won, the Competition shall end without the Landlord awarding the Prize.

The Landlord and its service providers including network providers, shall not be responsible for incorrect or inaccurate transcription of entry information, technical malfunction, lost or delayed data transmission, omission, interruption, deletion, line failure or malfunction of any network, computer equipment or software, the inability to access any website or online services or for any other reason beyond its control.
