3.	<b>Eligibility: Who may enter the Competition?"</b>	<p>To enter the Competition a participant ("<b>Participant</b>") must reside in Lower South Coast area, be 18 (Eighteen) years or older and in possession of a valid South African identity document or passport.</p> <p>Furthermore, a Participant needs to be in possession of an internet enabled device ("<b>Device</b>") such as a cellular phone, tablet and/or laptop, have access to a Facebook account and have access to the internet.</p> <p><b>Participants are advised that standard cellular or data rates apply.</b></p>
