2.	Promoter’s details:	This Competition is conducted and organized by Southcoast Mall (“Mall”) and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“Landlord”). In these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.

3.	<u>Eligibility:</u> Who may enter the Competition?”	To enter the Competition a participant (“Participant”) must reside in Lower South Coast area, be 18 (Eighteen) years or older and in possession of a valid South African identity document or passport. Furthermore, a Participant needs to be in possession of an internet enabled device (“Device”) such as a cellular phone, tablet and/or laptop, have access to a Facebook account and have access to the internet. Participants are advised that standard cellular or data rates apply.
4.	Who cannot enter the Competition?	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members, the Sponsor, employees of the sponsor, agent and/ or consultant.
