In these T's & C's, we refer to the above promoter(s) as "the Landlord" and the entrants as "the Participant(s)" or "you".

3.	<u>Eligibility:</u> Who may enter the Competition?"	To enter the Competition, a Participant must reside in South Coast and be 16 years or older. If under 18 years, the Participant must be able to show consent by a guardian or parent and be accompanied by such guardian or parent, if the Participant receives a prize. If under 18, the parent or guardian must accompany the participant when redeeming the prize.
4.	Who cannot enter the Competition?	The Competition may not be entered into by any tenant or their staff, director, member, partner, employee, agent, consultant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.

		None of the prizes are transferable and will not be changed, deferred, or exchanged for cash for any reason whatsoever.
11.	How will the Winner/s be informed?	<p>The Landlord will contact the Winner/s using direct messaging on Facebook and telephonically.</p> <p>If the Landlord is unable to contact or reach the Winner within 14 (Fourteen) days of having announced the Winner, the Entry by that person will be disqualified and the Landlord shall be entitled to perform a further electronic selection to determine another winner. That winner will also be contacted using direct messaging on Facebook and telephonically, as soon as reasonably practicable.</p>
