<b>2.</b>	<b>Promoter's details:</b>	This Competition is conducted and organized by Southcoast Mall (“ <b>Mall</b> ”) and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ <b>Landlord</b> ”). In these T's & C's, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
<b>IMPORTANT INFORMATION</b>		
<b>3.</b>	<b><u>Eligibility:</u> Who may enter the Competition?”</b>	To enter the Competition, a Participant must reside in South Coast and be 16 years or older. If under 18 years, the Participant must be able to show consent by a guardian or parent and be accompanied by such guardian or parent, if the Participant receives a prize. If under 18, the parent or guardian must accompany the participant when redeeming the prize.
<b>4.</b>	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any tenant or their staff, director, member, partner, employee, agent, consultant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.

All entries that are incomplete, damaged, defaced or illegible will be void and not eligible for a prize.</p> <p>Upon compliance with(I) – (ii) OR (III) above a Participant will automatically be deemed to have entered the Competition.</p> <p>There are no additional charges for participating in the Competition.</p>
7.	<b>Limitation on entries</b>	A Participant may enter as many times as they wish during the Competition Period. A participant can only win one of the four prizes.

9.	<b>Winners announced on:</b>	The four Winners will be announced on 18 February 2026, or at any such date the Landlord deems fit.
10.	<b>The prizes</b>	Each of the three winners of the Love Notes competition, shall receive a shopping voucher to the value of R 400.00 (Four Hundred Rand) The Winner of the Valentine's Digital Competition shall receive a voucher to the value of R500.00 (Five Hundred Rand)

<b>11.</b>	<b>How will the Winner/s be informed?</b>	<p>The Landlord will contact the Winner/s using direct messaging on Facebook and telephonically.</p> <p>If the Landlord is unable to contact or reach the Winner within 14 (Fourteen) days of having announced the Winner, the Entry by that person will be disqualified and the Landlord shall be entitled to perform a further electronic selection to determine another winner. That winner will also be contacted using direct messaging on Facebook and telephonically, as soon as reasonably practicable.</p>
<b>12.</b>	<b>Upliftment of prizes</b>	<p>Once the Winners have been announced, the winners must arrange with Centre Management for the collection of their prize. No Participant will have any claim against the Landlord for such a termination.</p> <p><b>15.2</b> The Landlord shall not be responsible for any loss or misdirected entries, including but not limited to entries that were not received due to any failure of hardware, software, or other computer or technical systems affecting participating in the Competition.</p> <p><b>15.3</b> Participation in the Competition constitutes automatic acceptance of the T's and C's contained herein and the Participant agrees to abide by the T's and C's.</p> <p><b>15.4</b> Winners may not win any Mall Competition more than once in a 30-day period.
