In these T's & C's, we refer to the above promoter(s) as "the Landlord" and the entrants as "the Participant(s)" or "you".

3.	<u>Eligibility:</u> Who may enter the Competition?"	<p>To enter the Competition a participant ("Participant") must reside in Lower South Coast area, be 18 (Eighteen) years or older and in possession of a valid South African identity document or passport.</p> <p>Furthermore, a Participant needs to be in possession of an internet enabled device ("Device") such as a cellular phone, tablet and/or laptop, have access to a Facebook account and have access to an internet enabled device such as a smart phone, laptop or tablet.</p> <p>Participants are advised that standard cellular or data rates apply.</p>
4.	Who cannot enter the Competition?
