COMPETITION TERMS & CONDITIONS (“T’s & C’s”)

Date these T’s and C’s were first published: 1 August 2022

These T’s & C’s, as may be amended from time to time, explain your rights and duties in respect of the Competition. If you take part in this Competition and/or accept any prize, these T’s and C’s will apply to you. Please read the T’s and C’s carefully and pay special attention to all the terms printed in bold.

1.	Competition name:	Be A Recycling Superhero
2.	Promoter’s details:	This Competition is conducted and organized by the Southcoast Mall (“ Mall ”) and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ Landlord ”). In these T’s & C’s we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
IMPORTANT INFORMATION		
3.	<u>Eligibility:</u> Who may enter the Competition?”	To enter the Competition, a Participant must not be older than the age of 13 years old, residing in the South Coast area. The Participant must be able to show consent by a guardian or parent and be accompanied by such guardian or parent, if the Participant receives a prize.
4.	Who cannot enter the Competition?	The Competition may not be entered into by any tenant of the Landlord, director, member, partner, employee, agent, consultant, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
5.	Competition Period:	This Competition will run from 28 June 2022 until 11 August 2022 (“ Competition Period ”).
6.	How to enter?	To enter the Competition, a Participant will be required, for the duration of the Competition Period to: <ul style="list-style-type: none"> I. Between 28 June 2022 until 28 July 2022 (“Submission Period”), Participants shall create an A4 drawing and/or painting artwork that illustrates how we can save our ocean life through recycling (“Artwork”); Artwork received after the allotted time frame will be disqualified. II. At the back of their Artwork, Participants must include their contact details (“Contact Details”), including their name, age, phone number, and the name of the school they attend.

		<p>III. Upon completion of step I. and II. Participants must navigate their way through the Mall to locate one of the entry boxes (“Entry Box”) located at each entrance to the Mall.</p> <p>IV. Once you have located the Entry Box, drop off your Artwork which contains your Contact Details (“Entry”). Artwork received after the 28th of July 2022 will be considered invalid and disqualified.</p> <p>The Landlord in its sole and absolute discretion, reserves the right to disqualify and immediately remove any Entry that fails to meet the aforementioned criteria, is offensive and/or is not related to the purpose of the Competition.</p> <p>Upon compliance with (I) – (IV) above a Participant will automatically be deemed to have entered the Competition. There are no additional charges for participating in the Competition.</p>
7.	Limitation on entries	A Participant may enter as many times as s/he wishes during the Competition Period and can only win once.
8.	How will the Winner/s be selected?	<p>At the end of the Submission Period, the Landlord shall select 20 (twenty) Entries that the Landlord believes are worthy of the prize and being selected as winners. The Top 20 Entries will be published on the Mall’s Facebook Page where Facebook users will be allowed to vote for their favourite Entry by commenting on the Competition post with the name and surname of the Participant as well as the school he/she attends of their favourite Artwork (“Comment”).</p> <p>The date for voting via the Mall’s Facebook Page by Facebook users is from 1 August to 11th August 2022. Once the voting period has expired, the Landlord will then announce the top 5 Artwork with the most likes as winners (“Winner”) for this Competition.</p> <p>The school with the most Entries will be selected as the winning school (“Winning School”).</p>
9.	Winner announced on	The Winners and the Winning School will be announced on the Mall’s Facebook Page by no later than 12 August 2022 or at such later date that the Landlord deems fit.
10.	The Prizes	10.1 The Winners shall each receive Milky Lane and Ramsgate Stationer (“ Participating Merchants ”) vouchers valued at R500.00 (Five Hundred Rand) (“ Prize ”) to spend at the Mall.

		<p>10.2 The Winning School shall receive a R 2500.00 (Two Thousand Five Hundred Rand) voucher to spend at the Mall.</p> <p>The Prizes are courtesy of the Landlord and the Participating Merchants and subject to the terms and conditions that may be imposed by the Landlord and the Participating Merchants from time to time.</p> <p>None of the prizes are transferable and will not be changed, deferred or exchanged for cash for any reason whatsoever.</p>
11.	How will the Winner/s be informed?	<p>The Landlord will use all reasonable efforts to contact the Winners through his/her Contact Details as provided in the Winner's Entry.</p> <p>The Winning School will be notified telephonically and/or <i>via</i> Email by the Mall marketing team.</p> <p>If the Landlord is unable to contact or reach the Winners within 14 (Fourteen) days of having announced the Winner, the Entry by that Participant will be disqualified. The Landlord will be entitled to thereafter to select another Winner. That Winner will also be contacted through his/her contacted details as provided in his/her Entry, as soon as reasonably practicable.</p>
12.	Upliftment of the Prize	<p>Once the Winner has been announced, the Winner accompanied by his/her parent and/or guardian must make their way to the centre management offices ("Centre Management") located at the Mall between 9h00 - 16h00 ("Trading Hours") Monday to Friday to uplift the Prize. The Winner's parent and/or guardian must: (i) appear in person; and (ii) be able to furnish a copy of his/her identity document or valid passport upon upliftment of the Prize .The Winner's parent and/or legal guardian acknowledges and accepts that she/he will be required to complete a waiver on behalf of the Winner before the Prize can be handed over. The Landlord reserves the right to withhold the Prize until the Winner completes same.</p> <p>The school representative of the Winning School must (i) produce a formal letter on the school letterhead and/or document of acceptance from the Winning School duly signed and stamped with the school stamp that he/she is a representative of the Winning School; and (ii) be able to furnish a copy of his/her valid identity document or valid passport upon upliftment of the Prize.</p>
